**SCHEDULE OF PAYMENTS:** Enclose deposit noted above with registration. The remaining balance is due and payable in four equal installments on or before the following dates: November 1, 2009; February 1, 2010; March 15, 2010; full tuition due by May 15, 2010. **Any installment paid late after your initial registration must include an additional \$35 late payment fee and will also result in the loss of any discounts/rebates/scholarships previously granted.** Those registering after May 1, 2010 must enclose full payment. In addition to the tuition above, additional camp fees will be billed in late April 2010 for all campers. The fees vary with length of stay and cover laundry basket, field trips and camp store debit account deposit. Note that any amount remaining in the camper's store debit account at the end of camper's stay at camp will be refunded!

## PLEASE READ THE FOLLOWING AND SIGN BELOW:

The tuition fully includes the camp registration, all programs of instruction, all private lessons, room and board, supervision, and some craft materials. The tuition does NOT include transportation to and from camp, airport pick-up, musical instruments (except pianos and drums), out of camp trips, bed/bath linens or snack items and apparel available for sale at the Camp Store. Also, the cost of medications and mandatory participation in the CampMeds program for pill form prescription meds is NOT included in the tuition. In consideration of the Camper's enrollment and the payment of the appropriate tuition and fees, Camp Curtain Call, Inc. (Camp) agrees to reserve a place and to hire instructors, counselors and staff. The Camp's planning, hiring, promotion and expenses are directly determined by the number of enrollments during the Fall, Winter and Spring. The seasonal nature of summer camping precludes any tuition rebate/reduction/allowance for Camper's late arrival/early withdrawal/non-arrival/dismissal for cause. Registration & tuition payments are NOT transferable to any other camper.

Camp Curtain Call, Inc. is hereby appointed Loco-Parentis. If it is necessary to obtain off-camp medical/surgical/dental services for the Camper, such expenses shall be paid by the parent/guardian. Authority is granted without limitation to the Camp to assign in all medical matters to hospitalize treat/order injections/anesthesia/surgery for the Camper. The Camp will attempt to contact parents during a medical emergency. The parent is responsible for all pre-existing medical conditions, out of camp medical/surgical/hospital/pharmaceutical/allergy expenses, and for providing adequate quantities of medications and allergy serums to the Camp in original pharmacy containers and with a doctor's written instructions.

Campers may use ropes course elements, gymnastics equipment, wood shop tools and other hazardous equipment with supervision, may participate in any activity-trip including horseback riding, river rafting, and the circus activities organized by the Camp staff on or off the Camp grounds and may travel, when deemed necessary by the Camp, via public carrier. I, the undersigned, as a parent or guardian of a Camper, individually or on behalf of a Camper, recognize these risks and other unnamed risks that are inherent to the Camp program, and agree to assume these risks by allowing my Camper to participate in these programs. I/We waive my/our rights to sue, maintain action against, or recover from any activity sponsor (Camp Curtain Call, Inc.), staff persons, or any other professional thereof, for any injury to or death of a participant engaged in any activity. Therefore, I/we agree to assume all risks.

I/We, as a parent or guardian of a Camper, individually and on behalf of the Camper, hereby release, discharge and agree to indemnify Camp Curtain Call, Inc. its director(s), officers, employees, and cooperating organizations, from all liability for damage, injury, or illness to the Camper or his/her property relating to or deriving from his/her presence at the Camp and its cooperating organizations, or participation in or travel to or from activities.

Camp Curtain Call, Inc. is not responsible for damage/loss/safety of musical instruments/clothing/personal equipment brought or used during the Camper's stay. The Camp specifically advises the Camper not to bring jewelry/valuables to Camp.

The Camper and his or her parents agree to abide by the Camp rules and regulations for the health/safety/welfare of the campers and the Camp community. Smoking, possession of, or use of tobacco/ narcotics/ liquor or other intoxicant, non-prescription drug or any weapons on or off the Camp grounds will result in immediate dismissal without rebate. Parents and Camper consent to the unannounced search of his/her belongings, luggage, vehicle, etc. by camp officials while such property is on camp premises. Camper may not leave the grounds without the permission of the Camp director(s). Violation of these rules or other reasonable regulations will result in dismissal from the Camp without tuition rebate. The Camp reserves the right to dismiss any camper whose conduct is unsatisfactory or detrimental to the Camp's best interest without tuition rebate. In the event of Camper's dismissal, Parent agrees to immediately drive to camp to pick up Camper or to make immediate flight reservations at Parent's expense to have Camper flown home from an airport near the Camp.

Enclosed with this agreement is the required deposit noted on the front page. Tuition payments will be refunded in full less \$495.00 processing fee on July 1, 2010 for all enrollments received before December 31, 2009 if requested in writing before March 1, 2010. For registrations received during the calendar year 2010, tuition payments will be refunded less \$795.00 deposit on July 1, 2010 if requested in writing before March 1, 2010. No refunds will be made for cancellations after March 1, 2010. Any outstanding balance due precludes admission to Camp. The County of Carroll, Commonwealth of Virginia, shall have venue of any dispute that may arise out of this agreement or otherwise between the parties to which the Camp or its agents is a party and the interpretation and legal effect of this agreement shall be governed by the laws of the Commonwealth of Virginia.

The Camp Curtain Call program may include public performances and permission is hereby given for the Camper to take part in such performances on/off Camp grounds without compensation. Camp Curtain Call, Inc., its agents or assignees may use photographs/statements/articles/names/music/art/films/videotapes of/by the Camper in promoting Camp/Camp-related activities/publications/advertisements and exhibitions.

The parent/guardian represents that he/she has full authority to enroll Camper in the Camp, to authorize participation in activities and provision of medical care and to contract as foresaid. This agreement constitutes the full understanding of the parties and cannot be modified except in writing signed by the parties.
